

General Release and Wavier of Liability

I, as parent/guardian of the participant, hold harmless and release and forever discharge the Creative Drama Studio and its involved persons from any and all claims and demands whatsoever based upon any accident, illness, injury, property loss or damage or any other consequences arising or directly or indirectly resulting from my child’s/ family’s participation with the Creative Drama Studio, including any attorney’s fees. Furthermore, I understand that the Creative Drama Studio does not have medical or liability insurance to cover participants in the event of injury, accident, property losses, or other such occurrence in connection with these activities, and specifically release and hold harmless the Creative Drama Studio from any liability for medical care arising from these activities.

This release and waiver of liability is in favor of and shall inure to the benefit of the Creative Drama Studio and its members, directors, officers, representatives, agents, employees, successors, assigns, and any and all persons or entities on the Creative Drama Studio’s behalf who may be liable (collectively “its Representatives”) and, further, shall be binding upon myself and my heirs, personal representatives, successors, and assigns. I do hereby fully and finally release and discharge the Creative Drama Studio and its Representatives from, and indemnify and hold harmless the Creative Drama Studio and its Representatives from and against, any and all claims, demands, actions, causes of action, suits, whether at law or equity or otherwise, and/or liability of any kind or nature whatsoever, for property damage and/or personal injury, including death, and any and all losses, damages, expenses, costs, fees and/or liabilities of whatsoever kind or nature in connection therewith (including, without limitation,

attorneys' fees and court costs that may be incurred by the Creative Drama Studio) arising or resulting from , or in any manner by the negligence of the Creative Drama Studio or its Representatives or otherwise. I understand and fully recognize that this Release discharges the Creative Drama Studio and its Representatives from any liability or claim that I may have against the Creative Drama Studio with respect to any bodily or personal injury, including death, or property damage that may result from activities with the Creative Drama Studio, whether caused by the Creative Drama Studio's negligence or otherwise. I hereby release and forever discharge the Creative Drama Studio and any of its Representatives from any claim whatsoever which may arise or result from any first-aid treatment or medical service rendered in connection with activities with the Creative Drama Studio.
